5% FOR PUBLIC SAFETY WITH A POSITIVE FUTURE

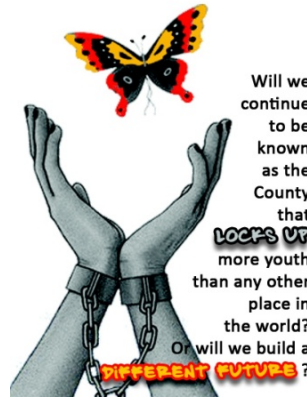
A 5% redirection of law enforcement dollars in Los Angeles City would provide \$174 Million annually for youth development.

\$174 Million: Establish a City Department of Youth Development with a priority to fund 30 youth centers; 350 FT peacebuilders/ intervention workers in schools and communities; and 15,000 youth jobs. Ensure a redirection of at least 5% of the city funds spent on suppression (LAPD, City Attorney) to fund the initiative with an understanding that youth resources and opportunities are essential and cost effective components of public safety. We are asking the Los Angeles City Council to pass a resolution in support, and to appoint a commission to develop a plan for the implementation of the department.

Youth centers would exist in communities throughout the city and would provide coordination of youth development programs, peacebuilding/ intervention efforts in surrounding neighborhoods and schools, as well as youth employment.

Key components of the department would include:

- ❖ A funding process that is open, accessible and transparent that provides youth development funding through an RFP process with oversight by a community funding board that includes government officials, youth, parents and community-based organizations.
- ❖ A training institute in partnership with a local community college and Cal State to establish certificate, undergraduate and graduate programs in youth development and non-profit management.
- ❖ Joint use agreements with school districts to maximize the use of schools as effective and engaging community spaces before and after school and on weekends.
- ❖ Coordination of peacebuilding (intervention) in neighborhoods and school districts, including linking intervention workers to youth centers and schools.
- ❖ Training and support for schools and communities in establishing alternatives to suspension, expulsion, arrest, court, detention and incarceration including the use in schools of Positive Behavior Intervention and Supports (PBIS), transformative justice and comprehensive school safety plans than engage all members of the school community in promoting and ensuring safe and positive environments.
